Speakers

Prof. Dr. Luís Menezes Leitão - “*The crisis effects on the real estate Portuguese market*”

LÚIS MANUEL TELES DE MENEZES LEITÃO was born in Coimbra in 1963. Has a degree (1986), the Masters (1991), PhD (1998) and aggregation (2005) in Law at the University of Lisbon. Conducted research in foreign universities, mainly Germany, Italy, France and the United States. Participated in conferences and seminars and courses and conferences held in Portugal, the United States, Italy,

Brazil, Mozambique, Guinea-Bissau and East Timor. He is Professor at the University of Lisbon and the Autonomous University of Lisbon, where he has taught courses in Civil Law - Law of Obligations and Contracts Law-Labour Law and Law on the Information Society. He was Chairman of the Board of the Faculty of Law of Lisbon (2002-2004). He is Vice-President of the Institute of Labour Law and the Institute for Consumer Law at the Faculty of Law of Lisbon. He is a member of the Pedagogical Council of the Center for Judicial Studies. He was a member of the Center for Fiscal Studies of the Directorate General of Taxes. He is a lawyer and jurist, and presently Vice-President of the Lisbon District Council of the Bar. There are dozens of books and articles published in the areas of Law of Obligations, Commercial Law, Labor Law and the Information Society. Among these works stand out Law of Obligations (3 vols.), Teaching the Law of Obligations, Responsibility Manager before the Business Owner on Portuguese civil law, unjust enrichment in Civil Law, Transfer of Credits, Guarantees of bonds, the Compensation for Clients in Agency Agreement, the Labor Code Annotated, Code of Insolvency and Corporate Recovery and Annotated Research Tax Law.

Prof. Dra. Nazaré da Costa Cabral – “*The crisis effects on budgetary Law*”

Nazaré Saldanha Póvoas da Costa Cabral – born in Lisbon, November 1971. Degree, Master’s and Doctorate in Law from the Faculty of Law of the University of Lisbon. Assistant Professor at the Faculty of Law of the University of Lisbon. Member of the Board of the Institute for Economic, Financial and Tax Law (IDEFF) of the Law Faculty of the University of Lisbon, where she is also part of the teaching staff. Deputy Director of the Journal Revista de Finanças Públicas e Direito Fiscal, published jointly by IDEFF and the Publisher Almedina. She has also lectured at other universities (the Faculty of Law of the University of Bissau, Lusophone University and Instituto Superior de Gestão), teaching various courses in the area of Legal and Economic Sciences. She has held various technical consultancy and legal advice positions in ministerial offices and been a member of certain working groups, especially in the area of Social Security. She is the author of various books and articles in the field of Public Finance and Financial Law and Public economy.
